



Our manual trading strategies are driven by macroeconomic analysis, market sentiment, and discretionary insights, allowing us to capitalize on nuanced opportunities that may fall outside the scope of automated models.



Trading Stradegy

At Financial Oracle SPC, we employ a sophisticated blend of algorithmic and manual trading strategies to navigate the global markets. This hybrid approach allows us to combine data-driven precision with human insight, delivering consistent performance across a variety of asset classes.



We combine the strengths of both automated and discretionary trading. 30–40% of trading volume is executed using proprietary algorithmic systems, primarily focused on FX pairs.

The remaining 60–70% of trades are executed manually, leveraging human expertise and real-time judgment.

Manual Trading Strategy

Our manual strategies are guided by a disciplined framework that integrates:

- Technical Analysis: Chart patterns, momentum indicators, trend tracking.
- Macroeconomic Data: Central bank policies, inflation figures, interest rates, and employment data.
- Fundamental Information: Market sentiment, geopolitical developments, and real-time news events.

This approach ensures agility and responsiveness in fast-moving markets, particularly in equities, commodities, indices, and fixed income instruments.

Risk Management

We are committed to rigorous risk controls, with a clearly defined threshold:

- Maximum Drawdown Limit 20%
- Our strategies are designed to operate within a controlled risk environment, with portfolio-level safeguards to protect investor capital during periods of elevated volatility.
